The undersigned company confirms the Marketing License in question, which includes the corresponding Maintenance Contract, for the below mentioned period from the date of signature of this contract on.

Supply Conditions

OxyTech engages itself to supply our company the following software and services for the validity period of the contract:

- 1. The program master file sent via Internet in the available languages. It is understood that the program will continue working at the end of the Maintenance Contract even if this is not renewed.
- 2. The following services (it is understood that the below mentioned services will be automatically shut off at the end of the Maintenance Contract period if it is not renewed):
 - a. inclusion of the customer's photometric and/or catalog data in the program master file
 - b. partial customization of the program logos
 - c. customization of the printouts logo
 - d. automatic program upgrade via Internet
 - e. all services included in Licenses R and B (see points 3 and 4)
- 3. One License R and related Maintenance Contract for LITESTAR 4D Open including:
 - a. the activation of the company WebCatalog on the OxyTech Internet Server or on our company Server
 - b. access to the reserved area of the OxyTech WebCatalog Server for continuous data updating
 - c. the automatic activation of our WebCatalog in LITESTAR 4D in both Open (free) and Pro configuration
- 4. Two Licenses B for LITESTAR 4D Pro (Single User License) and 1/2/3 year/s of the corresponding Maintenance Contract including, from the order's arrival and up to the expiration date, which will then be further extended to the end of the corresponding month:
 - a. automatic LITESTAR 4D program upgrade via Internet
 - b. daily communication and monthly summing-up on an Excel file of data regarding those designers, corporations, distributors etc. who have downloaded LITESTAR 4D Open from WebOxy (only for manufacturers)
 - c. 1/2/3 year/s of telephone and/or via Web-conference (Gotomeeting) on the use of the program equal to a total of 200€/year (Junior Assistance = 40€/hour Master Assistance = 60€/hour).

N.B.: any assistance provided outside the Maintenance Contract and/or after the credit has been exhausted will be automatically invoiced based on our Service Price List in force at the time the service is provided. The invoice will be issued when the limit of €100 is exceeded

N.B.: unused credit will be canceled upon expiry of the Maintenance Contract
